The Sûreté du Québec covers the territory of the Eeyou Istchee James Bay Regional Government. It is responsible for the enforcement of the municipal by-laws in addition to the Highway Safety Code.

This service is only available for notices of infraction starting with 100391 and clearly identified as follows: GREIBJ (Gouvernement régional d'Eeyou Istchee Baie-James). Here is a model of ticket that is acceptable for the payments:

Please note that **we do not accept** payment for the notices of infraction identified as “Direction des infractions” starting with **100400**.

PAYMENT METHODS

Before making your payment, you must be sure to pay your notice of infraction within 30 days after the notice is given. It is important to note that if you pay your notice of infraction after this deadline, a default judgement could have been entered in your file, which would cause additional fees.

Since the payment will not represent a final payment, legal proceedings could be started against you without notice if a balance remains unpaid.

By mail

The authorised methods of payment are by money order or cheque made to the order of the Gouvernement régional d'Eeyou Istchee Baie-James (GREIBJ).

1. Connect to your Caisse online
2. Click on Bill payment
3. Select Add a bill
4. Search for the supplier Gouvernement régional d'Eeyou Istchee Baie-James – Summary offense tickets. Validate the supplier.
5. Select Make a payment
6. Enter the reference number of your ticket and the SIPC code 9610.
10039180xxxxxxx9610. In the description, you must indicate the name of the person in whose name the ticket was issued.
7. A confirmation number of your payment will indicate if the transaction is complete.

1. Connect to your Bank online
2. Click on Connect
3. Click on Bill payment in the left side menu, then Add a bill
4. Search for the supplier Gouv. Reg. D'Eeyou – Summary offense tickets
5. In the reference field enter your notice of infraction number 10039180xxxxxxx without spaces or hyphens. If you have another notice of infraction to pay, do not forget to change the ticket number.
6. A confirmation number of your payment will indicate if the transaction is complete.

YOU WISH TO CONTEST A NOTICE OF INFRACTION?

You must register a not guilty plea on the attached response form to the notice of infraction. Your plea and explanations, if any, must be sent to the offices of the Eeyou Istchee James Bay Regional Government, 2 des Rapides Street, P.O. Box 819, Matagami, QC J0Y 2A0, at the latest 30 days after the notice of infraction.

You will be notified of the location, date and time of the proceedings by the registry of the Court of Quebec.

The defender that does not register a plea or does not pay the entire amount claimed will be deemed to be in default, without further notice, even in his/her absence. The ministère de la Justice will send you a notice of judgement in default and additional fees will be added to the initial amount and will be payable directly to the infractions and fines office at the Amos courthouse.
